

Whatever Happened To Article 78? –The Data

These data were developed by examining the Housing Court Reporter’s collection of landlord-tenant related Article 78 proceedings. The Housing Court Reporter is the only collection of all landlord-tenant cases for the relevant period and contains *all* decisions relevant to the questions presented in this paper.<sup>2</sup> Since all written opinions of the Appellate Divisions First and Second Department and of the Court of Appeals are reported and all such reports are in the Housing Court Reporter, the 100% sampling of written opinions represents a statistically valid sampling of the actual work of these courts in deciding cases of this nature.

While the main article describes these data as reflecting ten, five, and three years of work, in fact, they are 9.5, 4.5, and 2.5 years respectively, because the Housing Court Reporter is currently issued in half volumes, each covering a half year. The time of the writing of this article dictated that the first half of 2008 be the study period.

Note, from the point of view of the science of statistics, the lower the raw numbers one deals with, the less meaningful the trend observed. However, from the point of view of trend watching, things in the more distant past are less meaningful than things in the very recent past. So, there is a tension between having large enough numbers for statistically meaningful results, thus requiring a study over a longer period and having the most recent data which shows as a practical matter what the trends are. This study addresses both those concerns by working its analysis with regard to long term, intermediate, and short term results all reported.

For all of the following charts, “#” means the raw count of cases; “Affd” means the court has affirmed the decision of the agency; “Revd” means the court has reversed the work of the agency; “Mod” means the court has modified the work of the agency; “Rem” means the court has vacated the decision of the agency and remanded the matter back to the agency for further consideration. It should be noted that in many cases, such remands are at the agency’s request upon the agency’s discovery of its own error, such as an error in arithmetic. “CoA” means “Court of Appeals.” “1<sup>st</sup>” means “Appellate Division, First Department.” “2<sup>nd</sup>” means “Appellate Division, Second Department.”
